Sub: Grant of conditional permission to the Om Ayurvedic College and Research Centre, Near Crystal World, Roorkee Haridwar NH-58, village Panchayanpur, P.O. Daulatpur, Roorkee, Haridwar, Uttarakhand with 60 seats in BAMS (UG) course under Section 13A of the IMCC Act, 1970 for the academic session 2017-18- reg.

Sir/Madam,

I am directed to refer to the Ministry's order no. R.12011/51/2015-EP (IM-1) dated 26.10.2016 related to admission matter for the year 2016-17 intimating to develop the requisite infrastructure for 2nd professional for consideration of the case for the 2017-18 sessions.

2. The CCIM had carried out an inspection of the institution on 17-18.04.2017 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry.

3. The recommendations and visitation report of the CCIM have been carefully examined in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC), Ministry of AYUSH for the UG/PG course(s) for grant of conditional permission for the academic session 2017-18 vide Ministry's letter No.R.11011/03/2017-EP (IM-1) dated 12.06.2017 (available at Ministry's website <ayush.gov.in>) and it is found that the College is fulfilling the notified and approved criteria as follows:-

- (i) **Teachers:** For UG course: 90% eligible teachers, minimum 05 Higher Faculties (Professor/Reader) in 05 Departments in the college, at least 01 eligible teacher in each of 06 Departments for up to 60 seats and any 05 part time teachers;
- (ii) **Beds in hospital:** Minimum 60 beds in hospital of college for up to 60 UG seats;

- (iii) Minimum 120 patients per day in OPD during the year 2016 for up to 60 UG seats;
(iv) Minimum 40% bed occupancy for UG College in IPD during the year 2016;
(v) Equipment and instruments: Minimum 75% of required equipment as specified under the schedule VII of RMS or as per policy dated 12.06.2017; and
(vi) Other requirements: as specified in RMS 2016.

4. It has, therefore, been decided by the Central Government to grant conditional permission to the Om Ayurvedic College and Research Centre, Near Crystal World, Roorkee Haridwar NH-58, village Panchayanpur, P.O. Daulatpur, Roorkee, Haridwar, Uttarakhand with 60 seats in BAMS (UG) course for the academic session 2017-18 under section 13A of the IMCC Act, 1970, subject to the condition that the college shall fulfill the following requirements by 31st December, 2017 which will be verified for granting permission from the academic session 2018-19 onwards:

- (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016 by 31st December 2017.
(ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
(iii) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled in toto.

5. The fulfillment of the conditions attached to the permission given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2018-19.
